I understand that I shall not receive any additional residuals, royalties, or any other future or additional compensation for the rights granted herein.

There are no understandings, promises, or expectations regarding the use and ownership of the Photographs that are not expressly set forth herein. This Release is not to be construed against or in favor of either party on the basis of draftsmanship.
